Objectives :


1. Constituted for the redressal of the problems reported by the Students, faculty, staff of the institution.


GRIEVANCE REDRESSAL COMMITTEE

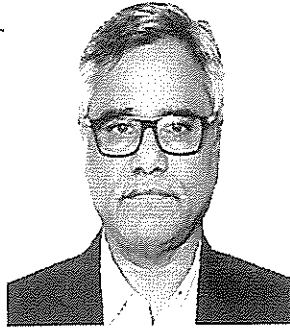
